ROTARY VOCATIONAL EDUCATION GRANT

Purpose:

To assist a Scappoose and St. Helens student (one \$1,500 grant for each school district) with funding to attend or continue attendance in a vocational institution or school.

Grant monies to be used solely for vocational training completed within two-year period. Grants are for vocational certificates and degrees only, not intended for Bachelor of Arts or Science degree.

Grant Goals:

1. Support students who want to attend vocational institutions or schools,
2. Address financial needs,
3. Reward
 - Initiative,
 - Career-directed achievement,
 - Students who have faced/may face significant life challenges.

Applicant Requirements:

1. Applicant must be accepted to a vocational school/institution or in the process of being accepted and meet eligibility and financial requirements of school/institution.
2. Demonstrate proficiency in the proposed area of study.
3. Be between the ages of 17 and 19 years of age.

Selection Process:

1. Applicant submits a completed application to your school counselor by **May 1, 2019**.
2. Applicant includes a letter of support from a teacher/ mentor/instructor or employer within a vocational area.
3. Rotary Committee reviews applications.
4. Rotary Committee Interviews finalists.
5. Rotary Committee mails grant announcement letters to applicants.

Award Process

1. **Required** – Grand award recipients must attend a Rotary meeting to accept the grant.
2. **Optional** – Rotary will have a representative attend and announce the grant at the senior assembly.
3. Grants are to be paid directly to the vocational institution/school.
4. Grants must be used before **April 15, 2021**.
